#### **NOTIFICATION**

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India read with the Notification No. 24/78/68-DH(S), dated 24th September 1968 of the Ministry of Home Affairs, Government of India and in supersession of the notification issued in G.O. Ms. No.15, dated 30th September, 2004 of the Law Department, Government of Puducherry and published as Supplement to the Gazette No. 41, dated 12th October, 2004 relating to the post of Lecturer in Law in Dr. Ambedkar Government Law College, Puducherry, save as respects things done or omitted to be done before such supersession, the Lieutenant-Governor, Puducherry hereby makes the following rules regulating the method of recruitment to the Group 'A' posts of Lecturer in Law in Dr. Ambedkar Government Law College, Puducherry, namely:—

- 1. Short title and commencement.— (1) These rules may be called the Government of Puducherry, Law Department, Group 'A' Post of Assistant Professor in Law in Dr. Ambedkar Government Law College, Puducherry Recruitment Rules, 2013.
  - (2) They shall come into force from the date of their publication in the official gazette.
- 2. Number of post, its classification, Pay Band with Grade Pay/Pay Scale.— The number of the said posts, its classification and the Pay Band with Grade Pay/Pay Scale attached thereto, shall be as specified in columns (2) to (4) of the Schedule annexed hereto.
- 3. Method of recruitment, age-limit and other qualifications.— The method of recruitment to the said posts, age-limit, qualifications and other matters relating thereto shall be as specified in columns (5) to (13) of the said Schedule.
  - 4. Disqualifications. No person,-
    - (a) who has entered into or contracted a marriage with a person having a spouse living; or
- (b) who having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Lieutenant-Governor, may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of these rules.

- 5. Power to relax.— Where the Lieutenant-Governor, Puducherry is of the opinion that it is necessary or expedient so to do, he may, by order, in consultation with the Union Public Service Commission and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
- 6. Saving.— Nothing in these rules shall affect the reservations and other concessions required to be provided for the scheduled castes, the scheduled tribes and other special categories of persons in accordance with the orders issued by the Government from time to time in this regard.
