## NOTIFICATION

In exercise of the powers conferred by the proviso to article 309 of the Cor read with the Notification No.F.5/4/65-GP., dated 11<sup>th</sup> January 1965 of the Gove Ministry of Home Affairs, New Delhi and in supersession of the Notification iss Ms.No.54/SO(E)/Edn./83, dated 31<sup>st</sup> May 1983 and published as supplement to Gaz 5<sup>th</sup> July 1983, save as respects things done or omitted to be done, before such Lieutenant-Governor, Puducherry hereby makes the following rules, regulating recruitment to Group "A" posts of "College Director of Physical Education & Sports (the Directorate of Higher and Technical Education, Puducherry, namely:-

- Short title and commencement.- (1) These rules may be called the Puducherry, Department of Higher and Technical Education Group "A" ( "College Director of Physical Education & Sports (Male/Female)" Recruitm
- (2) These rules shall come into force on and from the date of their publication gazette.
- Number of posts, its classification, Pay Band and Grade Pay / Scale of Pay the said posts, their classification, Pay Band and Grade Pay / Scale of Pay attached as specified in columns (2) to (4) of the schedule annexed hereto.
- Method of recruitment, age limit and other qualifications. The method of resaid post, age limit, qualifications and other matters relating thereto, shall be as specified to (13) of the said schedule.
- Disqualifications. No person,
  - a) who has entered into or contracted a marriage with a person having a sp
- b) who having a spouse living, has entered into or contracted a marriage wi shall be eligible for appointment to the said post;

Provided that the Lieutenant-Governor may, if satisfied that such marriage is the personal law applicable to such person and the other party to the marriage ar grounds for so doing, exempt any person from the operation of these rules.
