**NOTIFICATION**

In exercise of the powers conferred by the proviso to article 309 of the Constitution read with the Notification No.F.5/4/65-GP., dated 11<sup>th</sup> January 1965 of the Government of India, Ministry of Home Affairs, New Delhi and in supersession of the Notification issued by the Government of Madras, Ms.No.54/SO(E)/Edn./83, dated 31<sup>st</sup> May 1983 and published as supplement to Gazette of India, 5<sup>th</sup> July 1983, save as respects things done or omitted to be done, before such notification, the Lieutenant-Governor, Puducherry hereby makes the following rules, regulating recruitment to Group "A" posts of "College Director of Physical Education & Sports (Male/Female)" in the Directorate of Higher and Technical Education, Puducherry, namely:-

1. Short title and commencement.- (1) These rules may be called the Puducherry, Department of Higher and Technical Education Group "A" "College Director of Physical Education & Sports (Male/Female)" Recruitment Rules, 2015.  
(2) These rules shall come into force on and from the date of their publication in the official gazette.
2. Number of posts, its classification, Pay Band and Grade Pay / Scale of Pay for the said posts, their classification, Pay Band and Grade Pay / Scale of Pay attached as specified in columns (2) to (4) of the schedule annexed hereto.
3. Method of recruitment, age limit and other qualifications.- The method of recruitment, age limit, qualifications and other matters relating thereto, shall be as specified in columns (5) to (13) of the said schedule.
4. Disqualifications. - No person, -
  - a) who has entered into or contracted a marriage with a person having a spouse living,
  - b) who having a spouse living, has entered into or contracted a marriage with a person having a spouse living,shall be eligible for appointment to the said post;

Provided that the Lieutenant-Governor may, if satisfied that such marriage is in accordance with the personal law applicable to such person and the other party to the marriage or on other grounds for so doing, exempt any person from the operation of these rules.

5. Power to relax.- Where the Lieutenant-Governor, is of the opinion that
