

Item-4: Consideration for the approval for the authorised signatories of the RUSA Bank account.

As per the guidelines a set of TWO designated signatories at the state level and two designated signatories at the institutional level should be notified and both of them should jointly sign the cheques/issue electronic instruction for e-banking to operate all bank accounts. Hence it was recommended that the following may be approved to operate the account of RUSA:

- 1. State Level Account of RUSA : a) State Project Director
 - b) Member Secretary, PSHEC
- Institutional level Accounts : a) Principal/Director
 - b) Accounts Officer/Superintendent/ Senior most Faculty

SHEC Decision:

<u>Item-5</u>: Consideration for the approval for the appointment of Chartered Accountant for auditing of the RUSA Account.

As per the Draft Guidelines for consultation the accounts has to be audited annually by an independent Chartered Accountant appointed by the SHEC. The audited annual account must be submitted by the SHEC to the Mission Directorate. Hence the Council has to appoint a private Chartered Accountant.

SHEC Decision:

The Council approved for the appointment of an Independent Chartered Accountant for auditing the accounts of RUSA at State and Institutional Level, after following the government procedure.

Item -6: Any other matters with the permission of the Chairman.
