Sub:- Release of Grants to **Puducherry** as Infrastructure Grants to 11 Colleges under Rashtriya Uchchatar Shiksha Abhiyan (RUSA).

Sir,

I am directed to refer to the approval of the competent authority to release an amount of **Rs.2,75,00,000/- (Rupees Two Crore Seventy Five Lakhs Only)** as the 1st installment to be incurred to the Government of **Puducherry** as Infrastructure Grants to 11 Colleges, under Rashtriya Uchchatar Shiksha Abhiyan (RUSA) subject to fulfillment of all conditions as per RUSA norms. Under the initiative under reference, the Central Government shall provide assistance to the State Governments for various components, which are mentioned as per the guidelines under RUSA.

2. Pending final decision on the Centre State funding pattern for CSS schemes, in view of the larger devolution of tax resources to States as per the recommendations of 14<sup>th</sup> Finance Commission, the sharing pattern for this release is being modified to 50:50 basis, in accordance with the instructions of the Department of Expenditure, Ministry of Finance, Government of India, for General Category States. **Puducherry** comes under the General Category States. The first installment is of the Centre share as Infrastructure Grants to 11 Colleges is **Rs.2,75,00,000/-**. Further installments of the allocation shall be released by the Ministry only after the State Government concerned releases its committed share towards non-recurring expenditure and recurring grants, besides submission of the Utilisation Certificate by the State in respect of the installment of the Central grant released.

3. The sanction is issued in exercise of the powers delegated to Ministries under DFPR, 1978, as amended from time to time. Above grants are being released in accordance with the pattern of Assistance approved by the Ministry of Finance, Government of India. It is also certified that this Sanction is being issued in conformity with the rules and principles of the scheme.

4. On receipt of sanction letter, the Principal Accounts Officer may issue an advice to the Reserve Bank of India (Central Accounts Section), Nagpur for affording credit of the sanctioned amount to the balance of the State Government. The Principal Accounts Officer may forward a copy of the advice to the Accountant General and Finance Department of the State Government as well as Director, Higher Education of the State with a copy to the undersigned. The State will then transfer these amounts along with its matching grant to the RUSA bank account of State Higher Education (SHEC).
