Sub:- Release of Grants to **Puducherry** as Infrastructure Grants to 11 Colleges under Rashtriya Uchchatar Shiksha Abhiyan (RUSA).

Sir,

I am directed to refer to the approval of the competent authority to release an amount of **Rs.2,49,50,000/-** (**Rupees Two Crore Forty Nine Lakhs Fifty Thousand Only**) as pending of the 1st Instalment to be incurred to the Government of **Puducherry** as Infrastructure Grants to 11 Colleges, under the Rashtriya Uchchatar Shiksha Abhiyan (RUSA), subject to fulfillment of all conditions as per RUSA norms. Under the initiative under reference, the Central Government shall provide assistance to the State Governments for various components, which are mentioned as per the guidelines under RUSA.

2. Under RUSA, the Central Government shall provide assistance to the extent of 100% to **Puducherry**. The pending of the 1st instalment of the Central share as Infrastructure Grants to 11 Colleges is **Rs.2,49,50,000/-**. Subject to approval of the competent authority and fulfillment of all conditions as per RUSA norms, MHRD shall release **Rs. 2,49,50,000/-** (**Rupees Two Crore Forty Nine Lakhs Fifty Thousand Only**) of the allocation as the pending of the 1st Instalment. Further installments of the allocation shall be released by the Ministry only after submission of the Utilisation Certificate by the UT in respect of the instalments of the Central grants released.

3. The sanction is issued in exercise of the powers delegated to Ministries under DFPR, 1978, as amended from time to time. Above grants are being released in accordance with the pattern of Assistance approved by the Ministry of Finance, Government of India. It is also certified that this Sanction is being issued in conformity with the rules and principles of the scheme.

4. On receipt of sanction letter, the Principal Accounts Officer may issue an advice to the Reserve Bank of India (Central Accounts Section), Nagpur for affording credit of the sanctioned amount to the balance of the State Government. The Principal Accounts Officer may forward a copy of the advice to the Accountant General and Finance Department of the State Government as well as Director, Higher Education of the State with a copy to the

undersigned. The State will then transfer these amounts along with its matching share to the RUSA bank account of State Higher Education Council (SHEC).

5. The grant-in-aid is subject to adjustment on the basis of audited statement of accounts of **Puducherry**. Further, the accounts of **Puducherry** SHEC in so far as it relates to grants-in-aid will be open to inspection by the sanctioning authority and audit both; by the Comptroller & Auditor General of India or by any other designated by him and Internal audit by the Principal Accounts Office of the Ministry of Human Resource Development, Department of Higher Education, whenever it is called upon to do so.

6. The amount is debitable to the following three Heads of Demand No.60-Department of Higher Education:

Rs.1,89,43,750/- (General) from : Major Head 3602 Grants in aid to Union Territories, 04-Grants to Centrally Sponsored Plan Schemes 189- University and Higher Education, 02-General (General Education, 01-Rashtriya Uchchatar Shiksha Abhiyan (RUSA), 31- Grant in Aid, of the financial year 2015-16 (Plan).
- II. Rs.40,37,500/- (SC) from : Major Head 3602 Grants in aid to Union Territories, 04-Grants to Centrally Sponsored Plan Schemes 789- Special Component Plan for Schedule Castes, 24- General (General Education), 08- Rashtriya Uchchatar Shiksha Abhiyan (RUSA), 31- Grant in Aid, of the financial year 2015-16 (Plan).
- III. Rs.19,68,750/- (ST) from : Major Head 3602 Grants in aid to Union Territories, 04-Grants to Centrally Sponsored Plan Schemes 796- Tribal Area Sub Plan, 14-General (General Education), 02- Rashtriya Uchchatar Shiksha Abhiyan (RUSA), 31- Grant in Aid, of the financial year 2015-16 (Plan).

7. Accordingly, I am directed to convey the sanction of the President to release an amount of Rs.40,37,500/- (Rupees Forty Lakhs Thirty Seven Thousand Five Hundred Only) as the SC Component of the pending of the1st installment to be incurred to the Government of Puducherry as Infrastructure Grants to Colleges under Rashtriya Uchchatar Shiksha Abhiyan (RUSA).

8. The Expenditure of Rs.40,37,500/- (Rupees Forty Lakhs Thirty Seven Thousand Five Hundred Only) as the SC Component will be debited to Demand No 60-Department of Higher Education from Major Head 3602 Grants in aid to Union Territories, 04-Grants to Centrally Sponsored Plan Schemes 789- Special Component Plan for Schedule Castes, 24-General (General Education), 08- Rashtriya Uchchatar Shiksha Abhiyan (RUSA), 31- Grant in Aid, of the financial year 2015-16 (Plan).

9. A certificate of actual utilization of the grants received, for the purpose for which it was received, should be submitted to the Ministry within 12 months of the closures of the financial year.

10. The grant has been sanctioned in accordance with the pattern approved by the Ministry of Finance and is in conformity with the rules and principles of the scheme as approved by the Ministry of Finance.

11. Necessary Sanction ID has been generated.
