GOVERNMENT OF PUDUCHERRY CHIEF SECRETARIAT (EDUCATION-1) (G.O.Ms. No.24, dated 1 9 MAR 2015

NOTIFICATION

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India read with the Notification No.24/78/68-DH(S), dated 24th September 1968 of the Government of India, Ministry of Home Affairs, New Delhi and in supersession of the notification issued in G.O. Ms. No.108, dated 7th November, 2002, and published as a supplement to the Gazette No.51 of the 17th December 2002, save as respects thing done or omitted to be done before such supersession, the Lieutenant-Governor, Puducherry hereby makes the following rules regulating the method of recruitment to the Group 'A' post of Principal in Motilal Nehru Government Polytechnic College in the Directorate of Higher and Technical Education, Government of Puducherry, namely:-

- 1. Short title and commencement.- (1) These rules may be called the Government of Puducherry, Directorate of Higher and Technical Education, Group "A" Gazetted Post of "Principal in Motilal Nehru Government Polytechnic College Recruitment Rules, 2015.
 - (2) These rules shall come into force on and from the date of their publication in the official gazette.
- 2. Number of posts, its classification, Pay Band and Grade Pay/Pay Scale.- The number of the said post, its classification, Pay Band and Grade Pay/Pay Scale attached thereto, shall be as specified in column (2) to (4) of the schedule annexed hereto.
- 3. Method of recruitment, age limit and other qualifications. The method of recruitment to the said post, age limit, qualifications, and other matters relating thereto, shall be as specified in column (5) to (13) of the said schedule.
 - 4. Disqualification .- No person,-
 - (a) who has entered into or contracted a marriage with a person having a spouse living; or
- (b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said post;

Provided that the Lieutenant-Governor, may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of these rules.

- 5. Power to relax.- Where the Lieutenant-Governor, Puducherry is of the opinion that it is necessary or expedient so to do, he may, by order in consultation with the Union Public Service Commission and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
- 6. Saving.- Nothing in these rules shall affect the reservations and other concessions required to be provided for the scheduled castes, scheduled tribes and other special categories of persons in accordance with the orders issued by the Government from time to time, in this regard.

Promotion:

Head of Department in Engineering/Technology/Humanities and Science/Commercial Practice/Computer Applications in the Pay Band-4 Rs.37,400-67,000 with AGP of Rs.9,000 with 3 years' service in the grade rendered after appointment thereto on a regular basis and Ph.D. in the relevant subject.

Qualification for the post of Head Of Department (Engineering/Technology/Humanities and Science/Commercial Practice/Computer Application).

Note 1: Where juniors who have completed their qualifying/eligibility service are being considered for promotion, their seniors would also be considered provided they are not short of the requisite qualifying/eligibility service by more than half of such qualifying/eligibility service or two years, whichever is less, and have successfully completed their probation period for promotion to the next higher grade along with their juniors who have already completed such qualifying/eligibility service.

Note 2: For the purpose of computing minimum qualifying service for promotion, the service rendered on a regular basis by an officer prior to 01.01.2006/the date from which the revised pay structure based on the Sixth Central Pay Commission recommendations has been extended, shall be deemed to be service rendered in the corresponding Grade Pay/ Pay Scale extended based on the recommendations of the Pay Commission.

Deputation (Including short-term contract):

Officers under the Central Government or State Governments or Union Territories or Public Sector Undertakings or recognized Research Institutions or Universities or Semi-Government or Statutory or Autonomous Organization:

- (A) (i) Holding analogous posts on regular basis in the parent cadre/department; or
- (ii) With three years' service in the grade rendered after appointment thereto on a regular basis in posts in the Pay Band-4, Rs.37,400-67,000 plus Academic Grade Pay of Rs.9,000 or equivalent in the parent cadre/department; and
- (B) Possessing the Educational Qualification and experience prescribed for direct recruits under column (7).

The Departmental Officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment deputation/absorption. Similarly, deputationists shall not be eligible for consideration for appointment by promotion. (Period of deputation (ISTC) including period of

deputation (ISTC) in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Government shall ordinarily not to exceed 5 years. The maximum age limit for appointment by deputation (ISTC)shall not be exceeding 56 years as on the closing date of receipt of applications).

Note: For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to 01.01.2006/the date from which the revised pay structure based on the Sixth Central Pay Commission recommendations has been extended, shall be deemed to be service rendered in the Corresponding Grade Pay/Pay scale extended based on the recommendations of the Pay Commission except where there has been merger of more than one prerevised scale of pay into one grade with a common grade pay/pay scale, and where this benefit will extend only for the post(s) for which that grade pay/pay scale is the normal replacement grade without any upgradation.
