Sub:- Release of Grants to Puducherry as 2<sup>nd</sup> installment of Creation of University by Upgradation of Existing Autonomous College and Equity Initiative under Rashtriya Uchcharat Shiksha Abhiyan (RUSA).

Sir,

I am directed to refer to the approval of the competent authority to release an amount of Rs.1,50,00,000/- (Rupees One Crore Fifty Lakh Only) as 2<sup>nd</sup> installment of Creation of University by Upgradation of Existing Autonomous College and Equity Initiative at the central: state share of 60:40 to be incurred to the Government of Puducherry, under Rashtriya Uchcharat Shiksha Abhiyan (RUSA). Under the initiative under reference, the Central Government shall provide assistance to the State Governments for various components, which are mentioned as per the guidelines under RUSA.

2. In accordance with the instructions of the Department of Expenditure, Ministry of Finance, Government of India, vide File No.0-11013/02/2015-CSS&CMC Dated 17<sup>th</sup> August, 2016 for UT with Legislature, the funding pattern is revised to 60:40. Puducherry comes under the UT with Legislature. 2<sup>nd</sup> installment of Creation of University by Upgradation of Existing Autonomous College and Equity Initiative at the central: state share of 60:40 to be incurred to the Government of Puducherry under Rashtriya Uchcharat Shiksha Abhiyan (RUSA) amounts to Rs.1,50,00,000/- (Rupees One Crore Fifty Lakh Only). Further installments of the allocation shall be released by the Ministry only after the Government of Puducherry concerned releases its committed share towards non-recurring expenditure and recurring grants, besides submission of the Utilisation Certificate by the UT in respect of the installment of the Central grant released.

3. The sanction is issued in exercise of the powers delegated to Ministries under DFPR, 1978, as amended from time to time. Above grants are being released in accordance with the pattern of Assistance approved by the Ministry of Finance, Government of India. It is also certified that this Sanction is being issued in conformity with the rules and principles of the scheme.

4. On receipt of sanction letter, the Principal Accounts Officer may issue an advice to the Reserve Bank of India (Central Accounts Section), Nagpur for affording credit of the sanctioned amount to the balance of the State Government. The Principal Accounts Officer may forward a copy of the advice to the Accountant General and Finance Department of the State Government as well as Director, Higher Education of the State with a copy to the undersigned. The State will then transfer these amounts to the RUSA bank account of State Higher Education Council (SHEC).

5. The grant-in-aid is subject to adjustment on the basis of audited statement of accounts of Puducherry. Further, the accounts of Puducherry SHEC in so far as it relates to grants in aid will be open to inspection by the sanctioning authority and audit both; by the Comptroller & Auditor General of India or by any other designated by him and Internal audit by the Principal Accounts Officer of the Ministry of Human Resource Development, Department of Higher Education, whenever it is called upon to do so.

6. The amount is debitable to the following three Heads of Demand No.58-Department of Higher Education:

**Rs.1,16,25,000/- (General)** from : Major Head 3602 Grants-in-aid to Union Territory Government, 06- Centrally Sponsored Schemes 101- Central Assistance/Share, 33- National Education Mission : Rashtriya Uchchatar Shiksha Abhiyan (RUSA), 01- Rashtriya Uchchatar Shiksha Abhiyan (RUSA), 31-Grants-in-aid-General, of the financial year 2017-18.

III. **Rs.11,25,000/- (ST)** from : Major Head 3602 Grants-in-aid to Union Territory Government, 06- Centrally Sponsored Schemes 796- Tribal Area Sub Plan, 33- National Education Mission: Rashtriya Uchchatar Shiksha Abhiyan (RUSA), 01- Rashtriya Uchchatar Shiksha Abhiyan (RUSA), 31-Grants-in-aid-General, of the financial year 2017-18.

7. Accordingly, I am directed to convey the sanction of the President to release an amount of **Rs.11,25,000/- (Rupees Eleven Lakh Twenty Five Thousand Only)** as the **ST Component** of the 2<sup>nd</sup> installment of Creation of University by Upgradation of Existing Autonomous College and Equity Initiative at the central: state share of 60:40 to be incurred to the Government of Puducherry, under Rashtriya Uchchatar Shiksha Abhiyan (RUSA).

8. The Expenditure of **Rs.11,25,000/- (Rupees Eleven Lakh Twenty Five Thousand Only)** will be debited to Demand No.58-Department of Higher Education from : Major Head 3602 Grants-in-aid to Union Territory Government, 06- Centrally Sponsored Schemes 796- Tribal Area Sub Plan, 33- National Education Mission: Rashtriya Uchchatar Shiksha Abhiyan (RUSA), 01- Rashtriya Uchchatar Shiksha Abhiyan (RUSA), 31-Grants-in-aid-General, of the financial year 2017-18.

9. A certificate of actual utilization of the grants received, for the purpose for which it was received, should be submitted to the Ministry within 12 months of the closures of the financial year.

10. The grant has been sanctioned in accordance with the pattern approved by the Ministry of Finance and is in conformity with the rules and principles of the scheme as approved by the Ministry of Finance.

11. Necessary Sanction ID has been generated.

12. This sanction issues with the concurrence of Integrated Finance Division's Dy. No.535, dated 27.02.2018 and funds certified by the IF I Section vide their Dy.No.1260/17-IF.I dated 06.03.2018.
