#### GOVERNMENT OF PUDUCHERRY CHIEF SECRETARIAT (EDUCATION-I)

#### NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India read with the Notification No. 24/78/68-DH(S), dated 24th September 1968 of the Government of India, Ministry o Home Affairs, New Delhi and in supersession of the notification issued in G.O.
