ORDER :

Approval of the Lieutenant-Governor, Puducherry, is hereby accorded to constitute a “Selection Committee” for the formation of the first “Puducherry State Higher Education Council” for the Union Territory of Puducherry under Rashtriya Uchcharat Shiksha Abhiyan (RUSA), a Centrally Sponsored Scheme of Ministry of Human Resource Development, New Delhi, with the following members as per guidelines of RUSA.

2. The first Council will be appointed on the recommendation of a five-member selection committee is hereby constituted by the Government of Puducherry, whose members are as follows :

TWO eminent Scientist / Social Scientist.

- (1). Dr. M. P. Ramanujam, Scientist-cum-Environmentalist, Puducherry.
- (2). Dr. E.M. Rajan, Professor in Economics (Retd.) Former Principal, Tagore Arts College, Puducherry, who has guided many Ph.D. students.

ONE Former Vice-Chancellor of a State University.

- (3). Dr. S. Kumuda, Former Principal, Bhararthidasan Government College for Women, Puducherry, which was an autonomous body (in the absence of a State University in the Union Territory of Puducherry).

ONE Former Director of Institute of National Repute within or Outside the State

- (4). Dr. A.K. Dass, Former Director of National Institute of Diabetology, Trivandrum. (No.3 Sankaradass Street, Puducherry 605001.)

ONE Former Vice-Chancellor of a Central University

- (5). Dr. A.Gnamam, Former Vice-Chancellor, Pondicherry University.

3. The Director of Higher and Technical Education shall convene the meetings of the Committee and submit a report to the Government.
