WHEREAS, a Notification was issued vide G.O.Ms.No.57 dated 1st October, 2013 of the Chief Secretariat (Education), Puducherry, prescribing Rules and Regulations / Guidelines for the award of Perunthalaivar Kamarajar Financial Assistance to the students studying medical / engineering degree courses in the Unaided Private Professional Educational Institutions in the Union territory of Puducherry and to those students sponsored for the said courses under other States quota by the Ministry of Human Resource Development, Government of India, New Delhi;

AND WHEREAS, in para 2 of the said Notification, it has been provided that the said Notification shall be applicable only to the students admitted from the academic year 2011-12 to 2013-14 and that from the academic year 2014-15 onwards a new Scheme for financial assistance shall be devised;

AND WHEREAS, it has been now decided to make applicable the said Rules and Regulations / Guidelines for the award of Perunthalaivar Kamarajar Financial Assistance to the students admitted for the academic year 2014-15 also;

NOW, THEREFORE, the Lieutenant-Governor, Puducherry is pleased to order that the Rules and Regulations / Guidelines for the award of Perunthalaivar Kamarajar Financial Assistance to the students admitted through CENTAC pursuing professional (medical and engineering) degree courses in various Professional Educational Institutions in the Union territory of Puducherry, etc., notified in G.O.Ms.No.57 dated 1st October, 2013 shall be applicable to the students admitted for the said courses during the academic year 2014-15 also without any modification. This Scheme is not extended to the students admitted in the new Institutions / new Courses started in the academic year 2014-15 and also to any increased intake of seat in the existing courses from the academic year 2014-15.
