Kind attention is invited to the circular cited above wherein, in order to ensure public safety and to strictly enforce the practice of wearing helmets while riding two wheelers, the Government of Puducherry have notified the compounding fee for various offences and also instructed to impose spot fines of Rs.1000/- under Section 194D of Motor Vehicle Act, 1998, besides leading to disqualification from holding two wheeler licence for three months period for first offence, and with a similar penalty for the second/subsequent offences for those who are riding without wearing helmets.

Therefore, all the Head of Institutions of the U.T. of Puducherry requested to emphasize the importance and to insist to wear helmet by all the Faculties, Staff and Students of their respective institutions and to comply with Government Orders, accordingly.

#### CIRCULAR

Sub: Wearing of helmets by Government Servants / Students / Public - Strict enforcement - Reg.

\*\*\*

In order to ensure public safety and to strictly enforce the practice of wearing helmets while driving two wheelers, the Government of Puducherry have notified compounding fee for various offences and authorized the officers of the Police, Transport and Revenue Departments to impose spot fines for "compoundable offences' that do not require adjudication of the courts. A copy of the notification can be downloaded from the website: <a href="https://transport.py.gov.in">https://transport.py.gov.in</a>

- Now, riding without a helmet will attract a spot fine of Rs.1,000/- under Section 194D and lead to disqualification from holding license for three months for first offence with a similar penalty for the second / subsequent offences.
- 3. The Head of Departments / Institutions are therefore requested to emphasis the need for wearing helmets without fail to their employees and students (in case of Institutions), which is being emphasized for their personal safety. It may be recalled that, one is liable for penalty of Rs.1,000/- for not wearing helmet.
- 4. May kindly ensure strict compliance.
