MINUTES OF THE 9TH MEETING OF THE PROJECT APPROVAL BOARD (PAB) OF RUSA HELD ON $01^{\underline{ST}}$ DECEMBER 2015

The 9th meeting of the RUSA PAB was held on 01st December 2015 at 11:00 hrs. in the Conference Hall, Dept. of Higher Education, Shastri Bhawan, New Delhi under the Chairmanship of Sh. Vinay Sheel Oberoi, Secretary, Dept. of Higher Education, MHRD. This meeting was held through Video Conferencing where almost all States participated and the list of participants is placed at Annexure-I.

The Chairman PAB welcomed the members of the PAB and other participating States took up the agenda of the meeting.

AGENDA ITEM 1: CONFIRMATION OF MINUTES OF 8TH MEETING OF PAB HELD ON 2ND SEPTEMBER, 2015.

The PAB approved the Minutes of 8th Meeting of the PAB with the following amendments:

- Assam: The central share of Assam, indicated as Rs. 14.30 crores at page 25 of 8th PAB Minutes be amended to Rs. 19.8 crore, since 90% of Rs. 22 crore is Rs. 19.8 crore under Component Infrastructure Grants to Colleges.
- Bihar: (1) T.N.B College has been approved by 7th PAB under the component Infrastructure Grants to Colleges. Therefore, approval in 8th PAB under the same component for this college is not required. The name of the college is deleted from the list at page 27 of the Minutes of the 8th PAB meeting as uploaded on the Website (2) Three colleges Ram Dayalu Singh College, Muzaffarpur; SS College (Swami Sahjanand College), Jehanabad; and Marwari College, Bhagalpur have been approved both under "Infrastructure Grant to Colleges" and "Upgradation of existing colleges to MDC". Ram Dayalu Singh College, Muzaffarpur has already been approved for infrastructure grants in PAB 7 hence the name of the college may be deleted from the list of already approved colleges under upgradation to MDC in page no 26 of the Minutes of the 8th PAB. Further the names of the SS College (Swami Sahjanand College), Jehanabad; and Marwari College, Bhagalpur may be deleted from the list of colleges approved for infrastructure grants in page no 27 of the 8th PAB Minutes. Consequently the allocation as at page 29 of the 8th PAB Minutes is revised as under:-

- Rajasthan: The number of colleges approved under Infrastructure Grants to Colleges is 68 instead of 70 (page no. 13) as mentioned in the funding abstract of Rajasthan. Total funds approved for infrastructure grants to colleges may be read as Rs. 136 crore instead of Rs. 140 crore, central share may be read as Rs. 88.4 cr and State share may be read as Rs. 47.6 cr. Hence, total funds approved for Rajasthan may be read as Rs. 242 crore instead of Rs. 246 mentioned in the minutes. Subsequently the Central share may be read as Rs. 157.30 crore and State share may be read as Rs. 84.70 crore. Also colleges mentioned at S. No. 17 & 18 may be cancelled.
- **Sikkim**: Total funds approved for all the sanctioned components, may be read as Rs. 29.84 crore which is the correct sum, for the remaining plan period instead of Rs. 32 crore (page number 7). The Central share and State share may consequently be read as Rs. 26.856 crore and Rs. 2.984 crore respectively
- Maharashtra: State share against Infrastructure grants to colleges at page 23, be read as Rs. 3.5 crore as against 2.5 crore. The total consequently stands modified to Rs. 87.85 crore in lieu of Rs. 86.85 crore.

AGENDA ITEM 2: RUSA ACHIEVEMENTS

The Chair brought to the notice of the members of the PAB and the participating States about the progress made on RUSA since its inception. He specifically highlighted the improvements in the Student Teacher Ratio, increasing commitment by States to supporting Higher Education and the positive trend in recruitment of faculty. The attention of the States was drawn to increasing enrolment of students in Higher Education and lack of adequate infrastructure facility to match this increase. Consequently, there is a need for increasing financial support to improving infrastructure and other student centric facilities. Further, the States were urged to continue their commitment to increase their contribution to higher education as a percentage of their GSDP. He added that funding from RUSA should not be a substitute and should only be seen as a gap filling measure as far as States' funding to higher education is concerned. He, however, requested the States to ensure that the quality benchmark for faculty recruitment be maintained. The States were also advised to abide by the commitments given by them in the formation of the State Higher Education Councils through enactment by their State Legislature. The Higher Education Secretary strongly urged the States to give a fillip to the reform agenda of the RUSA initiatives namely, accreditation, affiliation, governance and administrative reforms.

He further alluded to the recent initiatives of MHRD in increasing capacity of the National Assessment and Accreditation Council (NAAC), so that the pace of accreditation of institutions can be improved significantly. He emphasized the need for States to undertake a periodic review of the NAAC status and progress of NAAC accreditation in States. He urged the States to share with the Department of Higher Education, MHRD a list of priority institutions whose accreditation is pending and awaited with NAAC. He also brought to the notice of the States about the recently launched National Institution Ranking Framework and urged the States to voluntarily get their institutions to participate in this framework. In doing so, the States should ensure that the reliability and accuracy of institutional data is maintained.

The National Mission Director informed the States about the component wise progress made under RUSA as against the targets sought to be achieved by the end of XIIth Plan. While, there has been significant progress achieved in certain components (some of which have exceeded the targets), in some cases the progress has not been satisfactory. She highlighted the need for States to actively submit the proposals under components, especially component 1 and 2. In this context, she also emphasized that in operationalizing these two components, the passage of an Act is a non-negotiable and necessary condition.

She emphasized the need for filling up of vacant faculty positions and urged the States to take the benefit of the faculty recruitment support, upon fulfilment of conditionalities. She expressed concern about the progress made on Component of equity initiatives and vocationalization on Higher Education and urged the States to participate more proactively in these areas. The States' attention was drawn to recent initiatives of the Ministry of HRD through MHRD regarding Kaushal Kendras and States were requested to work in tandem with this initiative in conceptualizing skill based proposals.

The Chairman discussed the States about the general improvement among various social groups in the Gross Enrolment Ratio and also encouraged the States to actively participate in the process of filling up AISHE data.

AGENDA ITEM 3: APPRAISAL OF SHEPS OF NEW ENTRANT STATES

A. DADRA AND NAGAR HAVELI

PAB Decision: The PAB approved a total amount of Rs. 0.9 crores as 100% Central Share for Equity Initiative for the remaining Plan period for Dr. A.P.J. Abdul Kalam Govt. College.

B. ANDAMAN & NICOBAR ISLANDS

PAB Decision: The PAB approved Rs. 41 crore as 100% Central Share under 3 components, Upgradation of existing College to MDC namely Mahatma Gandhi Government College, Mayabunder, N & M Andaman (Rs 4 crore), New Professional College in South Andaman district (Rs. 26 crore), Infrastructure Grants to 3 Colleges (Rs 6 crore) and Equity Initiatives for State as a Unit (Rs 5 crore) respectively for the remaining plan period.

The State representative made a strong plea for up gradation of an existing College to MDC, namely Mahatma Gandhi Government College, Mayabunder. The PAB considered the request and decided to approve this component, subject to the submission of DPR and their applying for NAAC. However, the approval is contingent on the enhancement of the physical target for XII Plan by the competent authority.

AGENDA ITEM 4: APPRAISAL OF ADDITIONAL PROPOSALS FROM STATES UNDER THEIR SHEPS.

A. ANDHRA PRADESH

PAB Decision: PAB accorded approval for Creation of a Cluster University in Kurnool with Silver Jubilee Govt. College (A), Kurnool as the lead college and two other participating colleges, namely KVR Govt. Colleges (W), Kurnool and Govt. Degree College (M), Kurnool. Further, the State should provide the request for re-appropriating to the cluster university component already released amount by MHRD (not utilized so far) to these three institutions under Infrastructure Grant to these Colleges. Consequently these three colleges will be eligible for additional amount of 49 crores under the Creation of Cluster University component. As a result, the approval given to these three institutions under Infrastructure Grant to Colleges (approved in 6th PAB) stands cancelled.

The PAB also accorded approval for upgradation to 2 MDCs (8 crore) and the 16 Government Colleges for Infrastructure Grants to Colleges. (32 crore).

The PAB approved a total of Rs 89 crore for three components viz. creation of a cluster university (49 crore), Infrastructure grants to 16 Colleges (32 crore) and Upgradation to 2 MDCs (8 crore), namely GDC, Bheemunipatnam, Visakhapatnam and GDC, Repalle, Guntur.

The PAB approved the creation of a Cluster University after taking into account the strong justification from the State of Andhra Pradesh and after examining the merits of the case. The State strongly argued for the need for a Cluster University in the region, considering the backwardness of the region and the recent bifurcation of the State. The State representatives argued that the creation of the cluster university would give an impetus to the quality education in the region.

B. ARUNACHAL PRADESH

PAB Decision: The PAB approved a total fund of Rs. 7.45 crores for 2 Components-Infrastructure Grants to Colleges (3) and Faculty Recruitment Support for the remaining plan period.

The PAB did not approve the request of the State for a new Professional College, considering the lack of demand and already available avenues for students to pursue engineering degrees from engineering institutions, both within the State and the region. Further, the PAB only recommended Faculty Recruitment Support in case of 2 Institutions, after taking into consideration the requirement and justification from the Institutions.

PAB Decision: The PAB approved a total of Rs. 132.54 cr for the remaining Plan Period which included 5 Universities under Infrastructure grants to Universities, 1 College for Upgradation to MDC, 17 Colleges under Infrastructure Grants to Colleges, Equity Initiatives and 1 Human Resource Development Centre (erstwhile Academic Staff College) for Faculty Improvement.

The Secretary (HE) urged the State Higher Education Department to secure the process of Court Orders expedited and if required, use the caveat route to ensure the speedy resolution of legal matters regarding appointment of faculty.

The PAB approved an additional 4 Infrastructure Grants to Colleges, taking the total to 17 after a strong justification was made by the State to include all institutions which were not approved under the proposed Cluster University. Taking into consideration that these 4 Colleges meet the programmatic norms, the PAB accorded approval under infrastructure grants to Colleges.

E. KARNATAKA

PAB Decision: The PAB approved a total of Rs. 284 Cr for the remaining Plan Period which includes 1 autonomous College to be upgraded to University, creation of 1 University by conversion of Colleges into a cluster, 4 Universities under Infrastructure grants to Universities, 1 College for Upgradation to MDC, 1 New professional College, 32 Colleges under Infrastructure Grants to Colleges.

Consequently, the Infrastructure Grant provided to the Autonomous College (6th PAB) stands cancelled and Central Grant released till date 37.5 lacs be adjusted against further release being made to this institution upon conversion to University.

The PAB approved the setting up of a new professional college in Gadag district, upon strong request from the State representatives, since there is a lot of demand for engineering education in the region and the lack of such a facility. Further, the PAB accorded approval to an

additional College (in all 32), taking into consideration all Government Colleges proposed by the State for support under infrastructure grants, which had valid accreditation.

PAB Decision: The PAB approved a total of Rs. 151.30 crore for the remaining plan period under 4 components- Infrastructure Grants to 4 universities under component 3 (Rs. 80 crore), Creation of 2 New Professional Colleges (Rs. 52 crore) under Component 6, Infrastructure grants to 3 colleges under component 7 (Rs. 6 crore) and Vocationalization of Higher Education for State as a unit (Rs. 13.30 crore).

The State made an ardent plea for setting up 2 Government supported Engineering Colleges, considering the lack of quality Engineering Institutions. The State representative also pointed

out that there are no vacant seats in all existing Government Engineering Colleges and therefore, there is an unmet demand for engineering education in Government Engineering Colleges. The PAB considered the State representative's views and approved the setting up of 2 Engineering Colleges. The State was requested to decide on the location of the Engineering colleges and provide justification for the creation of government funded engineering institutions in Tamil Nadu to the NMD. The PAB also noted that the State of Tamil Nadu should look at ways of enhancing quality of private engineering institutions in light of the fact that there are large number of vacant seats in these engineering colleges.

Consequent to the observations of the Expert Committee, in respect of the Kerala, Karnataka, Sikkim, West Bengal, M.P. and Uttarakhand, the PAB requested all Sates to submit their revised proposals. The States which have not submitted R&I proposals earlier, may submit fresh proposals for next round of expert committee assessment, taking into consideration the broad parameters that have been developed to guide the States in the preparation of their R&I plans.

The PAB also brought to the notice of States on the need for revised/fresh proposals to adhere to certain parameters. The proposals should ideally contain a detailed narrative- Aims and objectives, scope, literature review, conceptual framework, detailed methodology, existing body of work, the implications of the proposed research to existing work and the contribution

of the proposed research to enhancing the understanding of existing knowledge, domain strength and track record of PI and individual scholars embedded in high quality institutions (preferable live NAAC Accredited Grade A, wherever applicable) that demonstrate scholarship and competencies in the proposed area of work. The proposals should clearly define outputs and outcomes with a clear plan of publication. The involvement of Institutions with long standing academic credibility and scholarship and the stature of Principal Investigator and other members of the team, in terms of high quality academic credibility, is an important prerequisite.

The consolidated State-wise and Component-wise approval by PAB is at Annexure-II.

AGENDA ITEM 6: REVALIDATION OF RUSA FUNDS FOR 3 UTs

PAB Decision: The JS (F&A) informed the PAB that the matter needs to be examined on file. The agenda was therefore not taken up for discussion.

AGENDA ITEM 7: CANCELLATION OF TWO COLLEGES UNDER INFRASTRUCTURE GRANTS TO COLLEGES FOR HIMACHAL PRADESH AND MANIPUR

A. Himachal Pradesh

PAB Decision: The PAB approved cancellation of the two Colleges, namely Govt. College Bassa and Govt. College Drang at Narla under Infrastructure Grants. The fund utilized by these Colleges may be adjusted with the 1st instalment of central share to be released for Cluster University (approved in 3rd PAB) after appraisal of its DPR. The final total sanctions under RUSA to the State of Himachal Pradesh post cancellation of these two Colleges is given below:

AGENDA ITEM 8: FLEXIBILITY IN RUSA NORMS FOR TWO COLLEGES UNDER INFRASTRUCTURE GRANTS IN HIMACHAL PRADESH

PAB Decision: The PAB approved relaxation (in the ratio of norms of 35%:35%:30% for New Construction: Renovation: Equipment mandated under RUSA) for Renovation (60%) and Equipment (40%) for Govt. College, Sunni; and Renovation (45%) and Equipment (55%) for Govt. College, Haripur (Manali) under infrastructure grants.

AGENDA ITEM 9: GIS MAPPING OF STATES AND GEO TAGGING APP

A Pilot initiative of GIS mapping and geo-tagging of RUSA approved Higher Education Institutions in select States of Nagaland and Tripura was undertaken by RUSA-TSG in partnership with ISRO. As a part of this initiative institution level data of RUSA approved

institutions, (with respect to a variety of parameters, including physical and financial status), was collected.

PAB Decision: The PAB approved the initiative and resolved that ISRO may be requested to submit a detailed proposal in this regard for a Plan.

ANY OTHER ITEMS WITH PERMISSION OF CHAIR

Maharashtra: The State Project Director, Maharashtra brought to be the notice of PAB the challenges being faced by the State of Maharashtra and other States in operationalizing the component no. 2 (Creation of University by Conversion of Colleges in a Cluster) upon PAB approval. She pointed out that the legislative process for enactment of university is time consuming and therefore the release of money from Govt. of India to States which have received approval for creation of a new university under this component should not be conditional in so far an enactment by legislative process is concerned.

She also requested the PAB to consider enhancing the 1st instalment of release from the current 25% to at least 40% in order for States to effectively implement the project in the initial phase.

PAB Decision:

Consequently, the PAB noted that an initial amount of 25% be released to the States as Central share upon approvals under both the components (Component 1 and Component 2) with a clear pre-condition that the State should enact the legislation within six months after release of the grant. However, the conditionality on submission of DPR would remain unchanged.

In so far as the enhancement of the fund release as 1^{st} instalment is concerned, the PAB also endorsed the view.

Meghalaya: The NMD urged State of Meghalaya which was present in the Video Conferencing to hasten up the process of submitting their State Higher Education Plan.

The meeting ended with vote of thanks to the Chair, the participating States and members of PAB.
