- 2. This Grant is subject to the following conditions:-
 - The Grants-in-aid amount shall be deposited in the bank account especially opened for this scheme and a. will be utilized for the purpose for which it has been sanctioned by the MHRD.
 - A certificate of actual utilization of Grants-in-aid shall be furnished in accordance with GFR 212(1) in b. the form GFR 19A
 - c. The unspent balance amount of Grants-in-aid released during the year along with interest accrued on the deposited amount if any, shall be brought forward to the subsequent year as part of the scheme fund and shall be accounted in the Utilization Certificate issued in GFR 19A
 - d. The grants-in-aid shall be utilized in a time bound manner and in any case not later than three months from the closure of the financial year.
 - The Society shall get its accounts audited by the Chartered Accountants and audited statement of financial accounts shall be submitted to the Government during the subsequent financial year as required under GFR 212
 - f. The accounts of the Society shall be open to inspection by the Sanctioning Authority and audit by the Directorate of Accounts and Treasuries / Accountant General.
 - g. The Society shall maintain subsidiary accounts of the Grants-in-aid received from Government as required under Rule 210
 - h. Annual Report of the Society shall be submitted to the Government duly approved by the Institution's Governing Body.
 - The annual accounts of the Society should be completed within 6 months of the end of financial year. i.
