AICTE is in receipt of representations from the various State Governments to extend the last date of admission to all Engineering Courses (Diploma, Diploma lateral entry, UG & PG) till 31<sup>st</sup> December, 2020 considering late announcement of CET result in some of the States due to Covid 19.

Considering the request of various State Governments, AICTE in partial modification in their earlier circular dated 18-11-2020 has decided as under:

*“The last date for admission to Engineering Courses is extended upto 31<sup>st</sup> December, 2020 in only those cases where counselling and admission had not started due to delayed CET of the state or where counselling has yet not been over with a rider that classes were not started for more than 15 days to take care of the academic requirements of the students to avoid academic loss.”*

Please refer to this office circular No. AICTE/AB/SCR/Circular/2020-21 dated 01-09-2020 and letter of even number dated 15.10.2020 (copies attached) on the subject cited above.

2. In order to avoid financial hardship faced by the parents due to COVID-19 prolonged conditions in the Country, and request from various State Governments and ongoing admission process of IIT's and NIT's, it has been decided to partially amend Sl.Nos 4, 6 & 8 of the revised academic calendar for Academic Year 2020-21 issued on 13-08-2020 as under: -

3. Accordingly, consequent on partial amendment of the revised academic calendar for academic year 2020-21, it is clarified that the revised date for cancellation of seats of Technical Courses with full refund is 30<sup>th</sup> November 2020. In the event of student withdrawing before 30<sup>th</sup> November 2020, the entire fee collected from the student, after a deductions of the processing fee of not more than Rs. 1000/- (Rupees One Thousand only) shall be refunded by the Institutions. It would not be



permissible for Institution to retain the School/Institution leaving Certificates in Original. In case, if a student leaves the course after 30<sup>th</sup> November 2020 and if the vacated seat is consequently filled by another student by the last date of admission i.e. 5<sup>th</sup> December 2020, the Institution must refund the fee collected after a deduction of the processing fee of not more than Rs. 1000/- (Rupees One Thousand only) and proportionate deduction fee of Tuition fee and hostel rent, where applicable. In case the vacated seats after 30<sup>th</sup> November, 2020 is not filled by the Institution till 5<sup>th</sup> December, 2020, the Institution should refund the Security Deposit and return the original documents. The Institutions should not demand fee for the subsequent Semester/Years from the students cancelling their admission at any point of time. Fee refund along with the return of Certificates should be completed within 7 days of cancellation.

4. All AICTE approved Institutions/Universities are directed that full refund of fees be made on account of cancellation of admissions/migration of students except PGDM/PGCM up to 30<sup>th</sup> November, 2020 for this very session as a special case. Therefore, on cancellation/ withdrawal of admission of technical courses (except PGDM/PGCM) up to 30<sup>th</sup> November, 2020 the entire fee collected from a student be refunded in full after deduction of not more than Rs. 1,000/- as processing fee.

It is intimated that AICTE vide circular dated 13-08-2020 has issued revised calendar for A/Y 2020-21. Subsequently vide circular dated 15-10-2020 the last date of admission to all Engineering Courses (Diploma, Diploma lateral entry, UG & PG) was extended to 30-11-2020 except PGDM / PGCM for whom separate dates have been mentioned in revised Academic Calendar for A/Y 2020-21.

Instances have been observed that Management and ODL Institutions are also implying the last date of admission as 30-11-2020 while the circular dated 15-10-2020 is only for Engineering Courses (Diploma, Diploma lateral entry, UG & PG).

In view of the above clarification all Management and ODL institutes are requested to adhere to the previous academic calendar as circulated vide dated 13-08-2020. The circular dated 15-10-2020 is not applicable to theses Institutes / Courses.
